**Regular Program:**

**Refund Policy:** Camp will receive a full refund for participants that cancel from the program. For terminations/early departures, notify ICCP immediately and pay the participant a prorated amount for salary. ICCP will then consider a prorated refund of the ICCP fee.

Fee	\$400 - Fee is due with the application	Negotiable Guideline: Pay should be equivalent to a U.S. staff person performing the same job, but also taking their Travel expenses into consideration.

**Refund Policy:** Camp must notify ICCP in writing of any cancellations at least 15 days of the DS-2019 start date to be eligible for a \$200 refund.

**Trainee Program:**

7 – 12 Months	\$900 + Insurance at \$58.50 per month	Negotiable Guideline: Pay should reasonably cover living expenses for training period.
13 – 18 Months	\$1000 + Insurance at \$58.50 per month	Negotiable Guideline: Pay should reasonably cover living expenses for training period.

<i>Extension of Training plan</i>	\$300 (up to maximum of 18 months (78 weeks) + Insurance at \$58.50 per month.	
<i>Replacement DS-2019 due to loss or errors where ICCP is not at fault</i>	\$75	
Proof of participation letter (for past participants)	\$300 (non-refundable)	

**Refund Policy:** ICCP will refund 100% of the accident/illness insurance and 50% of the program fee to host site upon receipt of written notice at least 15 days of the visa start date. Host sites that terminate participants or if participants leave the program early should notify ICCP immediately and should pay the participant a pro rated amount for salary. ICCP will then consider a prorated insurance refund, calculated using the remaining number of weeks on the training plan.
