In the event of a fee increase, additional fees may be required to maintain coverage. Failure to maintain insurance coverage is a violation of J-1 visa regulations. | Cancellation (visa denied/withdraw from the program): 100% Insurance fee is refundable if written notice of cancellation is received by the International YMCA <u>within 15 days of the DS-2019 program start date.</u> Early departure/termination: a pro-rated Insurance Fee refund is granted if written notice is received by the International YMCA within 5 days in the event of ending the program earlier. Refund will be calculated <u>based on the number of months of insurance remaining</u> using the date written notice is received as end date. |
| SEVIS | *SEVIS Fee \$180.00 SEVIS Fee is due with the application. | Non-Refundable. |

Refund Policy: Non-refundable once the International YMCA secures the placement of the participant. In the event the International YMCA is not able to secure a placement or recruit the participant in 3 months, a \$400 refund will be issued. | \$500 Above amount is in addition to Program Fee, SEVIS Fee and Insurance Fee. |
| Expedited Service Fee (<i>Non-refundable</i>): 3-day review and DS form processing. Does not apply to new host sites. | \$500 |

* **SEVIS** is the U.S. Government's Student & Exchange Visitor Information System (SEVIS). The SEVIS Fee is required of all J-1 Trainees/Interns and a receipt is required at the visa interview. The fee is \$180, it is set by the government, and it is forwarded directly to the government.

** **NEW SITE VISIT FEE.** J-1 visa regulations require sponsors to conduct site visits to host organizations that have fewer than 25 employees or less than \$3 million in annual revenue and have not previously participated in a program sponsored by YMCA.

*** **FACE TO FACE INTERVIEW.** It is required of all J-1 trainee/intern applicants. It is the choice of the applicant to decide to be interviewed either by overseas partners of the International YMCA or authorized representatives of the host company who are fluent in English. The interview must be conducted through an in-person meeting, or by video-conference or web-camera. Please visit our website for a list of approved International YMCA overseas representatives. **Please note that overseas partners will charge you a fee for this service.**

**** **HOST SITE TRANSFER.** YMCA will consider host site transfer only in extreme circumstances.
